Notes on contributors

Vincanne Adams is Professor of Medical Anthropology in the Department of Anthropology, History and Social Medicine at the University of California at San Francisco. She is the author of numerous articles and several books on medicine and social change in Nepal and Tibet, including *Tigers in the Snow and Other Virtual Sherpas* (Princeton University Press 1996), *Doctors for Democracy* (Cambridge University Press 1998) and *Sex in Development* (with S. L. Pigg, Duke University Press 2005).

Yildiz Aumeeruddy-Thomas received her Ph.D. in Ethnobotany and Terrestrial Ecology from the University of Montpellier. She is a research fellow at the Centre National de la Recherche Scientifique (CNRS-CEFE) and associated with the Institut de Recherche pour le Développement (IRD). Her fields of interest are ethnoecology and ethnobotany, the relationships between local knowledge/practices and global norms, vernacular, scientific and citizen knowledge, cognitive processes and social dynamics within local territories. Her publications include the co-edited volume *Himalayan Medicinal and Aromatic Plants: Balancing Use and Conservation* (IDRC-WWF 2005).

Chen Hua is Associate Professor at the Department of Anthropology, Zhongshan (Sun Yat-sen) University, Guangzhou, China. He has done research on medical anthropology and physical anthropology since 1982, with special emphasis on traditional medicines. He has published articles and books such as *Principles of Traditional Chinese Medicine* (in Chinese) and *An Introduction to Medical Anthropology* (in Chinese).

Sienna R. Craig is Assistant Professor of Anthropology at Dartmouth College, Hanover, New Hampshire. She earned her Ph.D. from Cornell University on the relationship between Tibetan medicine and biomedicine in contemporary Tibet, with a specific focus on clinical research and the standardization, commoditization and industrialization of Tibetan medicine production. She has conducted research on Nepal, Tibet and the greater Himalayan region. Craig is also the co-founder of Drokpa, a non-profit organization. Her works include the book *Horses like Lightning: A Passage through Mustang* (Wisdom Publications forthcoming).

Casey Hilliard is a Ph.D. student at McGill University. Her master's thesis examined the socio-political forces contributing to the formal development of Tibetan medicine in post-socialist Mongolia. Her current research interests centre on the social, cultural and political implications of the global health and fitness industry.

Craig R. Janes is Professor and Associate Dean in the Faculty of Health Sciences at Simon Fraser University, Burnaby, British Columbia, Canada. His present research interests include the globalization of Asian medical systems, international public health, maternal and child health, social epidemiology, and the political economy of global health services reform. He has applied these interests in Mongolia, Taiwan, the Tibet Autonomous Region in China, Samoa and the United States.

Yeshi C. Lama was an anthropologist, who completed her thesis at the School of Oriental and African Studies, University of London (2002). She was posted at the WWF Nepal Programme on mountain projects and programmes that seek to conserve biodiversity and promote sustainable livelihoods. Her research interests concerned ethnobotany and medical anthropology in Nepal, especially with regard to interactions between local and scientific knowledge systems, and biological and socio-cultural landscapes. She died tragically on 23 September 2006.

Fei-Fei Li is an Assistant Professor in the Computer Science Department at Princeton University. She also holds courtesy appointments at the Neuroscience Institute at Princeton. She earned her Ph.D. from California Institute of Technology. Her main research area is computer and human vision, including statistical modelling and cognitive neuroscience. From 1999, she has spent many years studying Tibetan medicine with physicians at Lhasa Mentsikhang, including a clinical trial of Tibetan medicine for gastrointestinal disorders.

Margaret Lock is the Marjorie Bronfman Professor in Social Studies in Medicine, and is affiliated with the Department of Social Studies of Medicine and the Department of Anthropology at McGill University. She is a Fellow of the Royal Society of Canada, was awarded the Prix du Québec, domaine Sciences Humaines, in 1997, and in 2002 the Canada Council for the Arts Molson Prize. Lock's monographs include *East Asian Medicine in Urban Japan* (University of California Press 1980), *Encounters with Aging: Mythologies of Menopause in Japan and North America* (UC Press 1993) and *Twice Dead: Organ Transplants and the Reinvention of Death* (UC Press 2002); her books have received numerous prizes. She has edited or co-edited ten other books and written over 160 scholarly articles. Her current research is concerned with post-genomic biology and its impact in the clinic and among families and the public at large.

Colin Millard first carried out research in medical anthropology in 1992 in Ladakh, the north-east Himalayan region of the Indian State of Jammu and Kashmir. Since that time he has maintained an interest in medical anthropology, parti-

cularly as it relates to Tibetan culture and medical practices in the South Asian region. In 2002 he completed his Ph.D. in the Department of Anthropology at Edinburgh University, which focuses on learning processes in a Bonpo medicine school situated in the valley of Dhorpatan in the Baglung district of west Nepal. He is presently based in Edinburgh, where he is undertaking a research programme at the Tara Institute of Tibetan Medicine.

Laurent Pordié is an anthropologist, Director of the Department of Social Sciences at the French Institute of Pondicherry and Research Fellow at the Centre de Recherche ‘Cultures, Santé, Sociétés’ (CReCSS), Paul Cézanne University at Aix-Marseille. He is the General Co-editor of the academic book series ‘Sous prétexte de médecines’ (with A.-M. Moulin), with Editions aux Lieux d’Etre, Paris. His works and publications mainly concern the contemporary social dynamics of Tibetan medicine, and the anthropology of development, including the books *The Expression of Religion in Tibetan Medicine* (FIP 2003) and *Panser le monde, penser les médecines* (Karthala 2005).

Geoffrey Samuel is a Professorial Fellow in the School of Religious and Theological Studies at Cardiff University. Since 1971, most of his research has focused on Tibetans, though he has also worked in South Asia and in Western societies. His specialist fields include the anthropology of Buddhist societies and of religion in South and South-East Asia, medical anthropology and the anthropological study of healing. At Cardiff, he is developing a series of research projects on mind–body processes in relation to healing, looking both at Tibetan medicine and yoga and at other Asian traditions, and also at the contemporary British usage of such techniques within the field of complementary and alternative medicine. He has produced a large number of publications, including the books *Mind, Body and Culture* (Cambridge University Press 1990), *Civilized Shamans* (Smithsonian 1993), *Healing Powers and Modernity* (Bergin & Garvey 2001, with L. H. Connor), *The Daughters of Hariti* (Routledge 2002, with Santi Rozario), *Tantric Revisionings* (Ashgate 2005) and *The Origins of Yoga and Tantra* (Cambridge University Press forthcoming).

Eliot Tokar practises Tibetan medicine in New York City, and is one of very few Westerners internationally to have received extensive textual and clinical training in this field by Tibet physicians such as Yeshi Dhonden and Trogawa Rinpoche. He was a nominee for the White House Commission on Complementary and Alternative Medicine Policy, and served as an adviser to the American Medical Students Association. He has lectured at institutions such as Washington University School of Medicine in St Louis, University of Pennsylvania School of Medicine and Princeton University. His publications concern the theory and practice of Tibetan medicine and the role of Tibetan medicine in the context of its current globalization.

Ivette Vargas received her Ph.D. in Indian and Tibetan Buddhism from Harvard University (2003) and is currently Assistant Professor of Asian Religions at Austin College, Texas. Her research interests concern the experiences of

suffering and illness in Tibetan and Indian narrative and ritual literature, and the role of gender within these experiences; healing rituals; and the interface between religion and medicine. She has conducted research in Nepal, Tibet and Taiwan. She has published extensively on Tibetan and Indian Buddhist traditions.
